DRIVING INSTRUCTOR PERMIT REQUIREMENTS - SCHOOL BUS

Driver training permits are governed by the Driver Training Schools, Driving Instructors and Training Vehicles Regulation 46/2006 under the Drivers and Vehicles Act. In order to be considered for a Manitoba Driving Instructor permit you must meet the following criteria:

Criminal Code

- During the five years immediately before the date you apply you must not have:
 - Two or more convictions under the Criminal Code of Canada by means of a motor vehicle or while driving or having care and control of a motor vehicle.
 - Any convictions under the Criminal Code (Canada) of an offence against a person, a sexual offence, or an offence involving moral turpitude.
 - Been convicted of a contravention of *The Human Rights Code* or the *Canadian Human* Rights Act or a similar Act of another province or territory of Canada.

Driver Record

- No suspensions or prohibitions from driving as the result of being convicted of an offence under The Drivers and Vehicles Act or The Highway Traffic Act or a regulation of these Acts.
- No suspensions or prohibitions from driving as the result of being convicted of an offence under the Criminal Code (Canada).
- During the three years immediately before the date you apply, you must:
 - Have held a valid full-stage licence (issued by a province or territory of Canada or by a state of the United States) for the class of licence you wish to instruct.
 - Not have had more than two violations of the *Driver and Vehicles Act* or the *Highway Traffic* Act. This includes violations under any similar Act or regulations in any other North American jurisdiction.
 - Not have had more than two at-fault accidents. This includes accidents in any other North. American jurisdiction.
 - Not have been convicted of a an offence under the Driver and Vehicles Act, Highway Traffic Act or a regulation of these Acts for which a demerit value of 10 or more was set out under the Driver Safety System Regulation.

NOTE: If you are not sure if your driver record and/or driving experience meet the criteria, please contact the Driver Training Permit Unit before proceeding with the requirements. **Driving Experience**

 School Bus applicants must provide confirmation by their employers on company letterhead of the following minimum mileage requirements during the four years immediately before the date of application: 120,000 kilometres or 2,500 hours in a School Bus

Providing you meet the criteria, you may proceed with the following:

Instructor Preparation Course (IPC)

Successful completion of the IPC is valid for three years from the date you begin the course.

Instructor Tests

We recommend you review Manitoba's Driver Handbook and Professional Driver's Manual as you have only **two** attempts to pass each of the tests. Test results are valid for one year. If you do not apply for an instructor's permit within the twelve months, you may be required to repeat the tests.

Complete the following tests:

- 1. Class 5 knowledge test a **maximum of three (3) errors** is permitted.
- 2. Class 5 practical (road) test a **maximum of six (6) General Errors** is permitted.
- 3. Knowledge test for <u>each</u> class of licence for which you wish to instruct (Class 2 School Bus Test) a maximum of three (3) errors is permitted for each test.

Knowledge and practical tests are scheduled by appointment only. Please consult the Driver's Handbook or visit our website http://www.mpi.mb.ca/english/dr_licensing/Winnipeg.html for details about making an appointment.

Once you have completed the instructor preparation course, knowledge and practical tests (Permit Unit will verify all tests have successfully been completed), and have all the necessary documents you are ready to submit your application. Please use the checklist on the next page; all items are required in order to determine your eligibility and process your application.
